2. **PROCUREMENT METHOD: Open Domestic Bidding**
3. Tenderers must, in order to be considered for the award of the contract, be registered with the Public Procurement Regulatory Authority (PPRA) in the following categories:

4. The tender is open to **100% Citizen Owned companies**.
5. Prescribed Reservation or Preference Schemes shall be applicable in this tender.
6. Preference margins will be applied to qualifying bidders in line with the prescribed Preference Schemes.
